### MEMORANDUM OF UNDERSTANDING BETWEEN

SAIFEE HOSPITAL

AND

SHRI PALANPURI STHANAKVASI JAIN ASSOCIATION

This Memorandum of Understanding (MOU) entered into this 1<sup>st</sup> day of April 2016 between Saifee Hospital Trust incorporated under Bombay Trust Act bearing registration no. E-5448 (Bom) having its facility at P.B.No. 3771, 15 / 17, Maharshi Karve Marg, Mumbai - 400 004. (hereinafter referred to as "Saifee Hospital") of the First Part,

Shri Palanpuri Sthanakvasi Jain Association, Opera House (hereinafter called as S.P.S.J. Association) having its registered office c/o Samir Diamonds, 910, 9<sup>th</sup> floor, Prasad Chambers, Opera House Mumbai-400 004 of the second part.

Whereas both parties are desirous of entering into an understanding in terms of which S.P.S.J. Association will promote the facilities of the hospital to its group members and in terms of which the Hospital will provide quality medical treatment to the patients referred to it by S.P.S.J. Association.

Now this MOU witnesses and it is agreed by and between the above named parties as follows:  
This MOU is extended to the members of S.P.S.J. Association only. No other individual or entity will be entitled for the benefit under this scheme.

1. Saifee Hospital agrees to provide In Patient, OPD treatment and Health Check up services for the patients referred by S.P.S.J. Association. S.P.S.J. Association will provide the hospital with a complete list of its members with their names, and membership number.
2. For all planned and elective admissions, OPD treatment and Health Check up of the patient S.P.S.J. Association agrees to issue Authority Letter furnishing details of the patient and signed by officers of S.P.S.J. Association. whose signatures are registered with Saifee Hospital. (Changes

if any in Authorised Signatories on behalf of S.P.S.J. Association must be intimated to Saifee Hospital immediately.

The patient referred by the S.P.S.J. Association will carry the prescribed Identity Card/letter issued by the S.P.S.J. Association.

3. Hospital will assist patients to get immediate admission and give appointments for health check up and OPD investigation. Patients themselves will be responsible for making the payment for all the above mentioned services.
4. The Hospital agrees to give preference on admission as per availability of a bed to patients referred by S.P.S.J. Association. In emergencies when a bed of the eligible class is not available, the Hospital will use its discretion in admitting the patient to a higher class and shift the patient to the desired class as soon as the room is available. However the patient will be billed as per the class of admission in this interim period. The right to admission shall be at the sole discretion of the Hospital.
5. S.P.S.J. Association. will refer patients preferably to only Saifee Hospital.
6. S.P.S.J. Association. will not interfere in the treatment and medical care provided to its beneficiaries.
7. Saifee Hospital will liaise with office bearer of S.P.S.J. Association who will work on behalf of S.P.S.J. Association for all issues.
8. Rules and regulations of the Hospital will be binding on the patients sent by S.P.S.J. Association.
9. Billing and Payment Terms shall be as under :
  - The interim and final bills will be submitted to the patient regularly which shall include complete and clear break up of Services, Procedures, Tests, Pharmacy bills, Doctors fees, Discharge card .The Payment of the bill is the sole responsibility of the patient.
10. Saifee Hospital agrees to give discount as mentioned below
  - 20% discount on in-patient bill excluding Doctor's fees, consumables, medicine implants and diagnostic tests done outside the hospital.
  - 10% discount on health check up packages.
  - 20% discount on all diagnostic tests done on OPD basis (including MRI and CT scan) excluding tests done outside the hospital.
  - 50% discount on Yoga
  - 25% discount on Gymnasium
  - 20% discount on Ayurveda

11. No discount will be given on the following services like-

- No discount will be given on other Hospital Packages viz Ophthalmic, Cardiology, Maternity, Cardio-Thoracic, Bariatric and any others packages.
- Bariatric Surgery, Cosmetic Surgery
- Prostheses for Total knee, hip, all other prosthesis / implants pertaining to other specialities.
- Implant Surgery including dental prosthesis, dental crown, bridge and implants.
- Stents for Angioplasty(s) including all consumables for angioplasty namely balloons, guide wires etc.
- Cosmetic Surgery for personality enhancement.
- Chemo Therapy Drugs
- Plastic surgery for revision of scars and congenital defects including all cosmetic procedures.
- IVF Treatment, Chemotherapy drugs, Immuno Suppressants, Monoclonal Antibodies,
- No discount will be given on Hospital Package.

12. Any amendments in the clauses of MOU can be effected as an addendum after a written approval from both the parties.

13. This Agreement shall come into force with effect from 1<sup>st</sup> April 2016 and will remain in force until terminated by either party giving 2 months prior written notice to the other and ensure settlement of all pending dues and formalities.




